#### How to use

Before use, carefully read the directions on the packaging and act accordingly.

Before use, shake the aerosol.

Hold the aerosol vertically. From a distance of 20-25 cm, evenly apply the lubricant to the inner side of the mechanism.

Chains are recommended to be processed from the inside along their entire length.

After 5-10 minutes, the mechanism will be ready for work.

**Conditions of storage and transportation of products:** Products are transported by any ground mode of transport in compliance with the rules of cargo transportation. Products in packaged form must be stored in premises that protect products from chemical influences and mechanical damage at a temperature not lower than minus 20C and not higher than plus 40C.

**Stability during storage:** 5 years from the date of manufacture. The date of manufacture is indicated on the bottom of the aerosol.
